ZenJob AG has successfully converted into a European Company (Societas Europaea, SE) with effect from December 21, 2023, and has been operating as ZenJob SE since then. Together with Julian Jantze (Legal Principal at ZenJob), the SE formation of ZenJob was advised on corporate law by YPOG and on employment law by PWWL.

In addition to the change of the legal form into an AG and the formation of the SE, the corporate law advice included in particular the adaptation of the corporate governance structure to the requirements of stock corporation and SE law.

Following constructive negotiations between the management and the SNB, the participation procedure was successfully concluded with an involvement agreement.
